

# MOTORSPORT RACING TRACK - STUDENT DESIGN COMPETITION

## INVITATION

The IIA Navi Mumbai Centre has decided to float an open 'ideas' competition that invites Students to submit competition entries for a **Motorsport Racing Track** in accordance with the conditions and instructions set as below.

It is not the intention of The IIA Navi Mumbai Centre to construct as of now but the competition is being promoted as an exercise in conceptualizing design and planning, to draw attention to the growing popularity of Motorsports in India and to inculcate a higher sense of public interest in matters inclusive of urban development, architectural aesthetics, responsible architecture, conservation and re-adaptation, design trends, building technology, green buildings, organic architecture, socially impactful design and other similar intent.

## ELIGIBILITY

**A.** The term 'Student' shall mean a bona fide student of an institution, qualifying examination which is recognized by the Council of Architecture, India.

## APPROVAL OF CONDITIONS

- A.** This competition is being conducted in accordance with the prevailing competition code published by Council of Architecture, Government of India.
- B.** The Competition can be assured that jury are conversant with the COA Code for evaluation in Architectural Competitions.
- C.** A copy of the competition condition has been filed with the Council of Architecture.
- D.** If you are desirous of submitting more than one scheme, you may do so with payment of further enrolment fee for each additional entry (if required). Each scheme should be submitted separately, and the participant must apply for further copies of relevant competition document for each additional scheme.

## PERSONS INELIGIBLE

No member of the jury shall take part either directly or indirectly in the competition. No member of the promoting body or organizing of the competition shall be eligible to compete or assist a Competitor.

## PROJECT BRIEF

Motorsport in India is seeing a sharp surge in popularity. India hosted a series of Formula One races in the past, but they were discontinued due to tax disputes and Motorsport not being recognized as a 'Sport'. Since 2013, that was the last major Motorsport event that took place in India. Although that is all about to change soon. Formula E and Moto GP have announced India as a venue for races in 2023 and India will soon have its own feeder series of F4 and F3 which will give a systematic way for aspirants to get into the international scene. The Aim of this competition is to design a Circuit where motorsport events can be carried out efficiently. Environmental impact and sustainability is a large factor that needs to be taken into consideration at a conceptual level.

## **ENTERING IN THE COMPETITION**

ENROLMENT TO THE COMPETITION IS FREE OF COST.
- B.** If your application for enrolment is in order, the same will be acknowledged  
By The Empowered Competition Committee (ECC)
- C.** The detailed competition guidelines, condition and Project Brief, Site details etc., will be issued  
to you on email.

## **JURY**

The following members have been appointed in the Jury to assist and advise on the conduct of the Competition, adjudicate on the designs submitted and make the award (state below name title and designation of each jury member).

## **PRIZES AND MENTIONS**

The Winner, two runners-up and, 'commendations' will be duly honored at a formal function and prize money, etc. will be distributed.

The promoter undertakes to accept the decision and the awards of the jury and within 3months of the date thereof to offer the following prizes and Citation at a formal function befitting the event.

- I.** To the author of the best design placed Winner **₹51,000/-**
- II.** To the author of the design placed as Runners-up **₹31,000/-**
- III.** The promoter has also set aside an additional sum of **₹18,000/-** For further awards for 'Commendations' to be allotted at the advice of the jury.

## **ANONYMITY**

Anonymity is expected to be strictly observed at all stages of the competition by the Competitors, by the jury, by the organization and by all those concerned with the competition.

## **QUERIES & CLARIFICATIONS**

Once you are enrolled and have officially obtained Competition Brief and all condition, you can(if found necessary) send a letter of clarification or queries by E-mail before 5 pm on 31<sup>st</sup> December and a reply to your queries will be sent to you and copy of such reply will be shared with other Competition for their information. Additional queries at a later stage will not be entertained.

## **SUBMISSION OF DESIGNS**

### **A. Submission as 'online'**

Competitors shall submit online as per the following instruction:

- I. Competition drawing in B/W, color, BIM or 3D laser scanned deliverables can be uploaded and submitted through Net, but the file size of each of the drawings should not be more than 20 mb, and you will have to indicate in a 3x3 cm box at right side top of all drawings, a '6-digit code' that will be issued to you.
- II. The total number of above drawing printable in A1 size shall be minimum 2 Nos. and not more than 4 Nos.
- III. The design Basis Report (if any) should be uploaded along with drawings.

## **DISQUALIFICATION**

- A.** The entry will not be considered if any of the instructions and timelines as per instructions in this document are not adhered to.
- B.** The entry will be liable to be disqualified if it is reliably established by the department. In such an unlikely event, the organization's decision will be final and cannot be contested by you.

## **JUDGING PROCEDURE**

- A.** A 'jury' consisting of an eminent panel of Architects, Expert Member & senior functionary of the establishment has been formed to select the entries as the winner, two runners-up and under 'commendation'
- B.** The 'Jury' will be assisted administratively by an Empowered Competition Committee (ECC) constituted of conducting the competition in a fair and transparent manner.
- C.** The ECC will organize the display of Entries, record the jury decisions and all related functions of the conduct of the competition.
- D.** The Jury will undertake its selection responsibility on (TBA) In-camera and your personal attendance during the final session if required will be intimated sufficiently ahead for planning and travel. Your travel and local hospitality cost will / not be met by us.
- E.** The Jury Award will be officially Announced before (TBA) to all successful and unsuccessful entries.

## **ANNOUNCEMENT OF AWARD AND EXHIBITION.**

- A.** IIA Navi Mumbai Centre will be publishing the prize-winning entry, the runners-up and other permeated entries design as per Jury and inform the Competitors and COA through e-mail. All the prize-winning designs, including a few unsuccessful entries, will be exhibited appropriately on the premises and in a designated venue suitable for public viewing. All the entries will also be displayed on the website/ portal.
- B.** The names of winning, permeated entries, and all the participants will also be publicized and published unless the Competitor wishes to remain anonymous.

## **RIGHTS**

- A.** The drawings, report, declaration and scale model of the winning or selected entries will be retained by the Promoters after disbursing the prize monies as awarded by the Jury.
- B.** IIA Navi Mumbai with due permission from the Competitors, may publish or publicize the designs.
- C.** All Competitors, including the winners and unsuccessful entries will be at the liberty to display or publish their works in other forums and formats subject to Non- Disclosure Clause if any.

## **SETTLEMENT OF DISPUTES**

In the case of any dispute initiated by either of the parties, the same will be referred to The Council of Architecture, which will appoint an Arbitrator for resolution
